

## **INTEGRATION OF THE CALL FOR SCHOLARSHIPS APPLICATIONS FOR THE 2025/2026 A.Y. TO STUDENTS ENROLLING AT THE UNIVERSITY OF PAVIA IN THE SECOND SEMESTER AFTER COMPLETING THE “FILTER/OPEN SEMESTER” AT ANOTHER UNIVERSITY**

**These provisions** integrate the call for applications issued by EDiSU Pavia for the awarding of scholarships for the 2025/2026 academic year (approved by resolution of the Board of Directors no. 54 of 26/06/2025, updated by decree no. 297 of 16/07/2026 and amended by resolution of the Board of Directors no. 13 of 28/01/2026), hereinafter identified as “*ordinary call for applications*”, and **concern the methods of awarding scholarships to students who enroll in the second semester at the University of Pavia after having completed the “filter / open semester” at the University of Pavia or after having completed the “filter / open semester” at another Italian university.**

These provisions refer to Ministerial Decree no. 447 of 11 July 2025 “*Modalities for the fruition of the benefits of the right to education in relation to the reform referred to in Legislative Decree no. 71 of 15 May 2025*” and take into account the provisions approved by Ministerial Decree no. 418 of 30 May 2025, Ministerial Decree no. 454 of 16 July 2025, and Ministerial Decree no. 1115 of 22 December 2025.

Without prejudice to the provisions of these supplementary regulations, all the contents of the *ordinary call for applications* for the awarding of scholarships for the 2025/2026 academic year, where applicable, are deemed to be confirmed. Consultation of this notice is mandatory when applying for benefits.

### **Art. 1 - Submission of the 2025/2026 academic year scholarship application only for students who completed the “filter/open semester” at a university different from the University of Pavia**

Students who have enrolled in the filter/open semester to access Medicine and Surgery study course (LM-41), Dentistry and Dental Prosthetics study course (LM-46) and Veterinary study course (LM-42) for the 2025/2026 a.y. at other universities and who are now enrolling in the second semester of the 2025/2026 a.y. at the University of Pavia, have the option to apply to EDiSU Pavia for the award of the scholarship for the 2025/2026 a.y..

Exclusively for the students referred to in the previous paragraph, the online application “*Benefits request for the 2025/2026 a.y. after Filter Semester at another university*” is available - by accessing the institutional website EDiSU Pavia ([www.edisu.pv.it](http://www.edisu.pv.it)) in the area “Online Student Services”.

After having correctly filled out all the required data, the online application must be CONFIRMED no later than 12:00 PM of FEBRUARY 23, 2026.

To apply online, it's **NOT necessary** to have already completed your second-semester enrollment for the 2025/26 a.y. at the University of Pavia; however, eligibility for the scholarship is recognized only for students who will appear to be enrolled in the second semester at the University of Pavia no later than March 10, 2026.

For students with income and assets in Italy, is mandatory to have the **2025 ISEE Certificate** for the right to university study, as indicated in art. 4.2.1 of the ordinary call.

For students with income and assets abroad (students residing abroad and/or with the family unit residing abroad), EDiSU Pavia proceeds directly to calculate the equalized ISEE (Indicator of the Equivalent Economic Situation Abroad). These students are required to submit to EDiSU Pavia all the documentation indicated in art. 4.2.2 of the ordinary call.

Please note that documentation must be submitted in original copy, duly translated, and legalized, if necessary, proving the composition of the family unit of origin, the income situation in 2024, and the assets situation of all members in 2024.

Documentation must be submitted **no later than 12:00 PM of February 23, 2026**, directly at the EDiSU Pavia counter located at Via Calatafimi 11 in Pavia (counter opened on Mon-Wed-Fri from 09:30 AM until 12:00 PM and on Tue-Thu from 02:00 PM until 03:00 PM).

If shipped via post office, it **must still arrive** at EDiSU Pavia (at the administrative headquarter in Via Sant'Ennadio, 26 – 27100 Pavia) **by February 23, 2026**.

The costs of sending and responsibility for delivery are borne by the student.

## **Art. 2 - Publication dates for provisional and final rankings (for students who completed the filter/open semester at a university different from the University of Pavia)**

The scholarship rankings are formulated according to the criteria and methods provided for in the ordinary call for applications.

The **PROVISIONAL RANKINGS** will be announced to interested students **by MARCH 10, 2026**, subject to any postponements communicated through the EDiSU website – news section; they will be published in the “[Online Student Services](#)” - “Ranking Results” area, accessible only to competition participants.

**N.B.** In the provisional ranking list, students from “off-site” municipalities or foreign states, will *temporarily* result as “commuters”.

**Any requests to review the outcome of the provisional rankings** must be submitted to EDiSU Pavia **no later than MARCH 15, 2026**.

Any requests for review must be submitted online only by accessing the area “[Online Student Services](#)” – “Ranking Results” – “Scholarship provisional ranking” section. The outcome of the review request will be communicated in the same section to the interested parties and, if accepted, will have effects on the final ranking.

The student required to submit the original foreign documentation for the calculation of the equalized ISEE will be able to fix the incomplete documentation by bringing the missing original documents to the counter of EDiSU Pavia (Via Calatafimi 11) within the deadline for submitting review requests (**MARCH 15, 2026**). Only in the case of incomplete foreign documentation, the student is not required to file for the application review.

The **FINAL RANKINGS** will be announced to interested parties **by MARCH 31, 2026**, subject to any deferrals communicated through the EDiSU website – news section.

**By adopting the final rankings, “beneficiaries”, “eligibles” (= eligible but non-beneficiaries) and “non-beneficiaries” students for the 2025/2026 a.y. scholarship are identified and the final geographical condition of each student is defined (referred to the second semester at the University of Pavia).**

Eligibility for the scholarship and the right to the benefit are recognized to students and maintained by them based on verification of the general conditions of participation in the competition and possession of the financial and merit requirements, including academic regularity, provided for in the ordinary call for applications.

All eligible students, enrolled for the first time in the first year of all courses, who have obtained an income score equal to or higher than the income score achieved by the last “Beneficiary” student (non-disabled) of the final ranking approved on December 4, 2025 (ranking of students enrolled for the first time in the first year of all courses), will be recognized “Beneficiaries” in the final ranking (ranking of students who have completed the filter / open semester at another university)

### **Art. 3 – Modes and times for proving the condition of “off-site” student**

Students residing in “off-site” municipalities or foreign countries, who have resulted in the provisional ranking, temporarily in the condition of “commuter”, if interested in the recognition of the “off-site” condition (even partial) must submit **no later than 15 MARCH 2026** suitable documentation to demonstrate **the availability of accommodation in return for payment for at least THREE (n. 3) MONTHS for study purposes** relating to the 2025/2026 a.y. (from September 2025 to September 2026). The documentation must comply with the provisions of Article 6 of the ordinary notice - paragraph “Geographical origin”.

This documentation must be submitted as an electronic document (upload) in the section “Rental Agreement Data - Filter Semester” present in the “[Online Student Services](#)” area (site: [www.edisu.pv.it](http://www.edisu.pv.it)).

Once the deadline of March 15, 2026, has expired, the EDiSU office will review the submitted documentation and will ensure that eligible students in the provisional ranking are recognized with the final geographical status of “off-site”, even partial, or “commuter”, which will be made public with the adoption of the final ranking.

Please remember that having “accommodation in return for payment” means owning:

- **a rental agreement** (or more than one) in the name of the student, or a parent, valid for at least 3 MONTHS referred to the academic year 2025/2026 and the related registration with the Revenue Agency (referring to the time of the contractual validity)  
*or*
- **certification of a private college** (colleges NOT managed by EDiSU Pavia) which shows that the student is a paying guest at the residential structure for at least 3 MONTHS referred to the a.y. 2025/2026.

In the absence of the submission of such documentation by March 15, 2026, students, although residing in municipalities classified as “off-site” or coming from foreign states, will be considered “commuters”.

## Art. 4 – Scholarship amounts

For the scholarship, the amounts awarded to beneficiaries' students are the annual amounts provided for by Article 6 of the ordinary call for application, amended by CdA Resolution No. 13 of January 28, 2026.

It should be noted that the amounts indicated in Article 6 of the ordinary notice for students recognized as "off-site" students, refer to those who have demonstrated to have accommodation in return for payment for least 10 months.

For the recognition of the scholarship increase associated with the **status of "off-site"**, it is taken into account the availability of accommodation in return for payment, for study purposes, at the headquarter of the course attended, or adjacent areas (i.e. in the municipalities considered on-site in relation to the **course location** => Annex C of the ordinary call for application) **for a period of no less than 3 months.**

The increase is calculated considering the number of actual months of possession of paying accommodation during the academic year, duly documented as indicated in Article 3, also considering the period potentially enjoyed during the filter / open semester.

## Art. 5 – Payment schedule

Students enrolled in the first year, who have been awarded as beneficiaries the final ranking, will receive the scholarship according to the procedures indicated in Article 11, letter a) of the ordinary call for applications with the following deadlines:

- **First installment:** starting from **May 2026** and in any case only after the student has completed the requirements indicated in the paragraph "Notice for the disbursement of the cash portion of the scholarship" of art. 11 of the ordinary call for applications (completion of IBAN section + "Statement for collection of scholarship" available in the [students' personal area of EDiSU](#))
- **Second installment:** will be paid by EDiSU only after it has been established that the student has obtained, within the maximum deadline of August 10, 2026<sup>1</sup>, the number of credits indicated in Annex B to the ordinary call for application.

<sup>1</sup> EDiSU, having consulted the University, will consider the results of the final examinations of internships in the medical, pharmaceutical and psychological areas carried out after August 10, 2026, as long as their results are recorded in the "Booklet" by October 31, 2026.

EDiSU also considers valid the exam results of the following teachings even if they are obtained after August 10, 2026, but ONLY if the exam results are registered by September 30, 2026: "Anatomy" to the "Medicina e Chirurgia" course.
